### *Working with DCF Series - Part I* *Improving Communication and Collaboration*

Continuing Medical Education Program

Tuesday, May 1<sup>st</sup> 12:10 – 1:00PM

This teleconference series will provide an overview of key processes and critical steps to working effectively with DCF. The program will address the confusion that has sometimes prevented a fully collaborative relationship between DCF and medical practitioners. The presenters will announce new systems designed to enhance communication including regional meetings and an agency focus on strengthening families and partnering with providers in the community.

This program will clarify the roles and responsibilities of MDs, foster parents, parents and DCF social workers in ensuring that DCF children receive proper medical care. Speakers will review how a child's legal status can affect how they receive medical care. The speakers will also review the DCF investigation process as well as the role of the provider during the process. The program will provide guidance on how to identify the legal guardian, tips on record-keeping systems as well as advice on responding to medical record requests.

Participants will be able to:

- Understand the roles and responsibilities of MDs, Foster Parents, and Social Workers in providing medical care for children in DCF's care;
- Understand how the legal status of a child affects their medical care;
- Understand DCF reporting and investigation process and practitioners' obligations as medical providers;
- Understand DCF policies and guidelines for the care of children in DCF care;
- Understand how the Differentiated Response System can provide support to families.

**Ricka Wolman, MD, MPH.** Dr. Wolman is Director of Pediatrics at the Connecticut Department of Children and Families where she is developing a system of ongoing care and monitoring for children in DCF's care. She has also served as medical Director of Maternal and Child Health for the State of Maine as well as the Associate Medical Director in the national office of the March of Dimes.
