immunization records from CIRTS to the new Immunization Information System (IIS) called "CT WiZ" to meet national standards for operations and interoperability. Nancy serves as the IIS Supervisor overseeing day to day operations of the IIS; managing immunization Contracts to ensure compliance with the Centers for Disease Control and Prevention (CDC) federal grant objectives; developing policies and procedures for system users including DPH staff, Immunization Action Plan (IAP) Coordinators, providers and school nurses; and overseeing IIS training implementation statewide with the goal of improving childhood immunization services at the point of clinical care and at the population level.

Danielle Reader-Jolley is an independent consultant with over twenty years of experience in immunization program activities and IIS technical support operations.
